## Water Heater - Customer Shopping Tips

**Currently there are no rebates available for Tankless Water Heaters**

- Be sure to ask your water heater dealer for a utility approved model
- Water heater must be 50 gallons or larger to qualify.
- Electric water heaters must meet the following minimum efficiency requirements:
